



Fanwar Palo Alto Day Camp

Information

Registration: All families must pre-register for this event. There are a limited number of spaces available. Registration and payment are required to save your spot. To register fill out registration form and e-mail to christopherpuma@fanwar.com or turn in to Christopher Melville at a Fanwar event. Reminder: We are a group of families that get together to hire a gamemaster. At most events, adults are required to remain on site. **HOWEVER:** because this event is all week and is a succession of weekdays, this requirement is being waived for this event only, provided you have emergency contacts on file with the organizer and your child does not pose a significant risk to the flow, safety, or management of the event. All children who do not have adults on hand to chaperon them must demonstrate that they are responsible and cooperative and cannot leave the premises for the duration of the camp hours.

Cost: The week costs \$300 per person. There is no extra charge for the materials and items that students make and get to keep.

Location: The day camp is being held at Mitchell Park in Palo Alto CA. We usually meet near the "Push" statue, but may have to relocate depending on what other events are happening in the park that week.

What to bring: Students need to bring a lunch, clothing for variation in the summer weather, as well as adequate sun protection and good athletic shoes. Costumes and props are also a wonderful addition to our events.

Food: As mentioned above, lunch is not provided and students must bring their own lunches for this event each day.

Schedule: We begin promptly at 9am every day and play until 12pm. We take an hour lunch break from 12-1pm and a role play only town setting from 1-2pm. We run a second session from 2pm-5pm. The morning is mostly active battles, skills building, and adventures. The afternoon is split between smaller battles and crafting sessions to make LARP items the students get to keep. (If you need early drop off or late pickup-contact me)

Physical Activity Release

Live Action Role Play (LARP) (the "Activity")

IN CONSIDERATION OF being permitted to participate in the Activity, the undersigned, on behalf of myself and my heirs, executors, administrators and assigns, hereby:

1. Release and forever discharge the Organizer and its employees, officers, directors, shareholders, affiliates, agents, representatives, successors and assigns (collectively the "Releasees") of and from all claims, demands, damages, costs, expenses, actions and causes of action (collectively the "Claims") in respect of death, injury, loss or damage to myself or property howsoever caused, arising or to arise by reason of

or during my participation and/or involvement in the Activity, and notwithstanding that any Claim may have been contributed to or occasioned by the negligence of any of the Releasees.

2. Indemnify and save harmless the Releasees from and against any and all liability incurred by any or all of them arising as a result of or in any way connected to my participation in the Activity.

3. Understands and acknowledges that the Organizer does not carry or maintain health, medical or disability insurance coverage for the undersigned and therefore agrees to assume responsibility for such insurance coverage on the undersigned.

4. Agrees that in the event that any provision of this Release and Indemnity is held to be invalid or unenforceable by any court of competent jurisdiction, the invalidity or unenforceability of such provision will not affect the remaining provisions of this Release and Indemnity which shall continue to be enforceable.

I understand that the undersigned will be held to a standard of conduct during this event. Failure to abide by safety rules will result in a warning or expulsion from the event. I also understand that these events may include special effects and costuming that is considered frightening to some children. I also understand that the undersigned may use and be hit by a foam weapon of some sort by other participants and/or staff during this event. I understand/have helped the undersigned to understand that I/they may decline to participate in any part of the event. I give MUSE and FANWAR permission and consent for photos/videos to be taken of the undersigned during activities, and for these to be used for promotions in brochures, press releases, and other media.

By signing up the undersigned for this event, I acknowledge and understand that the participant will be voluntarily engaging in activities that may involve contact and the risk of serious injury, permanent disability, or death, and may cause severe social or economic losses due to not only the participant's actions, inactions, or negligence, but also to the action, inactions, or negligence of others or conditions of the premises or of any equipment used. Further, I agree that I will not, nor will anyone acting on my behalf claiming by or through me, bring or maintain any suit in Court to assert any claim against MUSE, FANWAR and/or any instructors/assistant instructors/staff for any claim that I might have arising out of the undersigned participation in any activities performed by, directed by, or endorsed by MUSE, FANWAR or the instructors/assistant instructors. I agree to pay for any and all expenses (including but not limited to any medical expenses) that might relate to the participant's care and treatment.
